STATEMENT OF PUBLIC COMMENTS AND PARTICIPATION: Members of the public interested in addressing the City Council during this Special Meeting may **only** address the items which have been described in the notice of this Special meeting in accordance with Government Code

Section 54954.3(a). State Law prohibits the City Council from taking action or entertaining extended discussion on a topic not listed on the agenda. In order to conduct a timely meeting, the maximum time allotted for each comment shall not exceed three (3) minutes; Public Comments may be limited to 30-minutes.

Pursuant to Assembly Bill 361, for those interested in participating during the public comment period, you may address the City Council in person *or* call in to the City Clerk's office as listed below until the day of the meeting prior to the start of the "Public Comment" period, Friday, April 8, 2022. In person speakers will be addressed first, telephonic speaker cards will follow thereafter. *In person speakers will be required to fill out a speaker card provided at the door and turn it into the Deputy City Clerk prior to the Public Comment announcement period. Staff will number and call on each speaker card in the order received. The public can submit *speaker card requests telephonically* by calling (323) 887-1359, Staff will complete/number the speaker cards and speakers will be called in the order received during the City Council meeting.* Both in person speakers and speaker cards will be addressed during the "Public Comments on Agenda Items" period only. The City has also created an email address, ccpubliccomment@cityofmontebello.com, where the public can submit written comments up until, **Thursday, April 7, 2022 no later than 3:00 p.m. These comments will be submitted to all members of the City Council and may not be read aloud but will be entered into the record of the proceedings to the extent they relate to matters listed on the posted agenda or otherwise address matters/issues within the subject matter jurisdiction of the City Council.**
