### REGULAR BUSINESS

2. **MONTEBELLO MUNICIPAL GOLF COURSE RENOVATION PROJECT PHASE 3 (CP NO. 894-3) – AUTHORIZE NOTICE INVITING BIDS AND SPENDING PLAN**

**RECOMMENDATION: It is recommended that the City Council:**

1. Select Option 1 (Permanent Clubhouse) or Option 2 (Temporary Clubhouse) for the Montebello Municipal Golf Course Renovation Project – Phase 3 (CP No. 897-3) and authorize the City Clerk to publish the applicable Notice Inviting Bids (Attachment A); and
2. Approve the updated Total Project Budget/Spending Plan (Attachment B) for the selected option; and
3. Take such additional, related, action that may be desirable.

*The City Clerk's Office acknowledged one (1) speaker card. Said speaker card is on file at the City Clerk's office.*

*Councilmember Tamayo asked a clarifying question regarding "Attachment 3"; Assistant City Manager Salazar clarified that the Attachment was on page 14 of the agenda packet. Mayor Pro Tem Peralta asked for clarification on staff's recommendation and provided her support for a permanent clubhouse and expressed her interest in the City Council supporting a dog park. Mayor Torres supported Peralta's dog park interest and asked staff to research that option. In addition, Mr. Torres recommended that instead of using general funds, that revenues from Home2Suites and other specific funds be used for this project. Additionally, he suggested that proceeds from San Gabriel Valley Water be used to cover overages and unanticipated expenditures. Director Enriquez clarified that there are no budget appropriation recommendations on this item at this time. He stated that this conversation will be considered once the item comes back with bids. Assistant City Manager Salazar clarified that the Home2Suite funds are a part of the general fund.*

*Furthermore, Councilmember Jimenez expressed her concerns about the location of the dog park, stating that there are neglected parks on the south side that need attention. Further, she asked about the funding for the dog park. Assistant City Manager Salazar stated that there is residual hotel money that can be used for the campus and the purpose of the dog park. Additionally, she noted that it is at the discretion of the Council on what the funds can be used for, since it all goes into the general fund. Mayor Pro Tem Peralta made a general comment that, despite districts, all open spaces should be supported so that all residents can enjoy them. Mayor Torres also voiced his concerns regarding the rhetoric of who gets what in what districts. He offered to sit down with Councilmember Jimenez to identify funding for her district.*

*The following motions were made:*

*Mayor Pro Tem Peralta motioned for a permanent club house; seconded by Councilmember Tamayo; the motion was approved unanimously.*

*Mayor Pro Tem Peralta motioned to receive the current budget recommendation but to have staff review and evaluate the comments made by the City Council to avoid using general funds and explore the use of hotel revenues and other resources, seconded by Councilmember Tamayo; the motion was approved unanimously.*

*Mayor Pro Tem Peralta motioned to direct staff to review and evaluate a dog park, seconded by Councilmember Tamayo; the motion was approved by the following vote:*

**3. INTRODUCTION AND FIRST READING OF ORDINANCE NO. 2463 AMENDING SECTIONS 2.30.010 AND 2.30.130 OF THE MONTEBELLO MUNICIPAL CODE TO REINSTATE THE CIVIL SERVICE COMMISSION AND CHAPTER 2.44 OF THE MONTEBELLO MUNICIPAL CODE TO REINSTATE THE TRAFFIC AND SAFETY COMMISSION**

**RECOMMENDATION: It is recommended that the City Council:**

1. Introduce and conduct a first reading of Ordinance No. 2463, with waiver of a full reading, of an Ordinance amending Sections 2.30.010 and 2.30.130 of the Montebello Municipal Code to reinstate the Civil Service Commission and Chapter 2.44 of the Montebello Municipal Code to reinstate the Traffic and Safety Commission; and

2. Provide direction to bring this item back for a second reading and adoption at the next regular City Council meeting; and
3. Take such additional, related, action that may be desirable

*The City Clerk's Office acknowledged five (5) members of the public wishing to address the City Council. Speakers were provided three minutes to address the City Council and said speaker cards are on file at the City Clerk's office.*

*Assistant City Manager Salazar asked the City Council to reconsider this item as it would interfere with the City's recruitment process.*

*Mayor Pro Tem Peralta stated that since the Civil Service Commission was transformed into a Personnel Advisory Commission, it no longer addresses adverse actions, violations or employee relations issues and stated that the importance of reinstating this commission is to protect employees' rights and security of their jobs and to limit liability to the City. Human Resources Director, Nicholas Razo, clarified that grievances are still heard and there is a process for them to be heard. Councilmember Jimenez commended the Human Resources and Risk management team. She expressed her concerns if the Council were to move forward, stating it would be detrimental. She asked clarifying questions to the City Attorney regarding the language of the Ordinance. City Attorney Alvarez Glasman clarified that in 2017, his office addressed concerns regarding the municipal code on who has the right to certify the appointment list and, based upon the analysis, the personnel officer (City Manager), has the ability to certify the employee eligibility list and the Commission has the ability to hear appeals and challenges. He stated that he is not looking to change or alter the process, rather re-evaluate the long-standing language. Councilmember Melendez stated he has no issue with the Traffic Commission being reinstated. However, he does believe that reinstating the Civil Service Commission would pose a challenge and there are concerns/workforce challenges and that it would put public safety in jeopardy. He suggested a study session take place before the Council approves this item. Mayor Torres addressed comments in regards to this item and clarified that the Civil Service Commission is to serve as an oversight commission, and would not control the recruitment process nor would there be any delays in the hiring process. Furthermore, he explained that the City Manager is granted the authority to approve recruitment processes and ultimately, the City Manager retains authority and the Commission would just bring back valuable rights to the employees.*

*Director Razo addressed the Council in regards to how the Civil Service Commission would handle hearings; he noted there is already a long wait process and wanted to revisit the language on the Municipal Code.*

*Councilmember Melendez suggested a study session for this item or tabling it to have the City Attorney's office and staff have a deeper discussion. Councilmember Melendez motioned to reinstate the Traffic and Safety Commission and to have a study session for the Civil Service Commission, seconded by Councilmember Jimenez.*

*Mayor Pro Tem Peralta made a substitute motion to approve the recommendations as is, seconded by Mayor Torres; the motion was approved by the following vote:*

*Mayor Torres pulled Item No. 5 and 7 for discussion; Mayor Pro Tem Peralta motioned to approve Item No's. 4, 6, 8, and 9. It was seconded by Councilmember Melendez and the motion was approved unanimously.*

*During the discussion of Item No. 5, Mayor Torres noted he mistakenly pulled Item No. 5 when he meant to pull Item No. 4. City Attorney Alvarez Glasman asked for consideration to amend the motion to approve Items No. 5,6,8,9.*

*Councilmember Melendez motioned to approve Item No's. 5,6,8,9, seconded by Mayor Pro Tem Peralta; the motion was*

approved unanimously.

**4. HYRAP STREETS PROJECT FISCAL YEAR 2022-23 (CP NO. 897) – NOTICE OF COMPLETION**

**RECOMMENDATION: It is recommended that the City Council:**

1. Accept the HYRAP Street Project, Fiscal Year 2022-23 (CP No. 897) as completed by Manhole Adjusting Inc., and
2. Approve the recommended “Changes in Work” for the project in the amount of \$311,343 (Attachment A); and
3. Approve the Final Total Project Budget (Attachment B); and
4. Amend the Fiscal Year 2022-23 budget by increasing appropriations by \$61,602 in the Measure M Fund, Account No. 220-99-7116-100.897.30 (Measure M, Improvements Other Than Building, HYRAP Streets Project); and
5. Authorize the City Clerk to file the Notice of Completion with Los Angeles County Recorder (Attachment C) and authorize the City Manager to release the retention payment due to Manhole Adjusting, Inc. following the mandatory waiting period from the date of Notice of completion is recorded; and
6. Take such additional related action that may be desirable.

*Mayor Pro Tem Peralta motioned to approve the item as is; seconded by Councilmember Melendez; the motion was approved unanimously.*

**5. MONTEBELLO MUNICIPAL GOLF COURSE RENOVATION PROJECT (CP NO. 894) – ELECTRICAL SWITCHGEAR PURCHASE ORDER**

**RECOMMENDATION: It is recommended that the City Council:**

1. By a four-fifths vote of the City Council authorize the dispensing of a formal bidding procedure for the purchase of the electrical switchgear for the Montebello Municipal Golf Course Renovation Project (CP No. 894), in accordance with Montebello Municipal Code Chapter 3.20.050; and
2. Approve a contract with AAA Electrical Supply in the amount not-to-exceed \$128,000 for the electrical switchgear and authorize the City Manager to execute the Purchase Order; and
3. Take such additional, related, action that may be desirable.
