City Manager Alvarez announced the upcoming Budget Meetings to take place around the City. He invited the residents to attend and provide feedback. He also announced Angelica Palmeros' appointment as the Acting Assistant City Manager as of January 28th.

PUBLIC HEARING

4. **PUBLIC HEARING TO ADOPT RESOLUTION NO. 24-17 APPROVING THE PROPOSED SUBSTANTIAL AMENDMENT NUMBER THREE (3) TO THE FISCAL YEAR 2020-2021 CDBG/HOME ANNUAL ACTION PLAN TO CANCEL A CDBG FUNDED ACTIVITY AND REALLOCATE CDBG FUNDS TO AN EXISTING ACTIVITY**

RECOMMENDATION: It is recommended that the City Council:

1. Approve Substantial Amendment Number Three (3) to the Fiscal Year 2020-2021 CDBG/HOME Annual Action Plan; and
2. Adopt Resolution No. 24-17 approving the Substantial Amendment Number Three (3) to the Fiscal Year 2020-2021 CDBG/HOME Annual Action Plan; and
3. Take such additional, related action that may be desirable.

Director of Planning and Community Development Joseph Palombi provided a presentation of the item.

City Manager Alvarez discussed the improvements in Fire Station 56, noting that CDBG funding for the Senior Project had been reallocated to the fire station. However, he added that staff secured additional funds to complete the remaining improvements at the Senior Center.

Mayor Melendez opened the Public Hearing at 8:21 p.m.

The City Clerk's Office acknowledged three (3) members of the public wishing to address the City Council. Speakers were provided three minutes to address the City Council.

Mayor Melendez closed the Public Hearing at 8:25 p.m.

Councilmember Peralta motioned, seconded by Mayor Pro Tem Tamayo, to approve the item; the motion was approved unanimously.

REGULAR BUSINESS

5. **APPOINTMENT TO FILL DISTRICT 4 CITY COUNCIL VACANCY**

RECOMMENDATION: It is recommended that the City Council:

1. Conduct interviews of applicants and make an appointment to fill an existing vacant City Council Seat for the term ending in December 2026; and
2. Take such additional, related action that may be desirable.

City Attorney Alvarez-Glasman explained the proposed process to the City Council and Candidates.

The process will proceed as follows: Each candidate will have the opportunity to deliver a two-minute oral statement, followed by a question from each Councilmember. Candidates will have one minute to respond to each question.

The City Council selected the following interview questions:

1. Mayor Melendez - Can you describe your overall experience, to include work, volunteer and/or community involvement, and how that has prepared you for this opportunity.
2. Mayor Pro Tem Tamayo - How do you balance the needs of the community or organization with your own values and priorities?

3. Councilmember Peralta - What program or services that the City provides would you like to see more of and how would you suggest improving them?

4. Councilmember Alonzo - How do you approach making difficult or unpopular decisions?

The City Clerk's Office acknowledged fifteen (15) members of the public wishing to address the City Council. Speakers were provided three minutes to address the City Council and said speaker cards are on file at the City Clerk's office.

Mayor Melendez asked for nominations for candidates.

Mayor Melendez nominated Joella Valdez.

Mayor Pro Tem Tamayo nominated Danielle Romero

Mayor Melendez asked each of the Council members to cast their vote for one of the two nominees.

1. Councilmember Peralta voted for Danielle Romero.
2. Councilmember Alonzo voted for Danielle Romero.
3. Mayor Pro Tem Tamayo voted for Danielle Romero.
4. Mayor Melendez voted for Joella Valdez.

Mayor Melendez congratulated Danielle Romero and announced that the oath of office would be administered at the conclusion of the meeting.

6. FISCAL YEAR 2024-25 SECOND QUARTER BUDGET UPDATE, CITY COUNCIL BUDGET PRIORITIES AND COMMUNITY BUDGET FORUM

RECOMMENDATION: It is recommended that the City Council:

1. Receive and file agenda report and the presentation on the Fiscal Year 2024-25 Second Quarter Budget Report, City Council Budget Priorities and Community Feedback; and,
2. Amend the Master Position Control to Adjust Staffing in the Transit, Parks and Recreation, Fire and Public Works Departments (Attachment C); and,
3. Approve the updated Salary Resolution No. 25-19 (Attachment D); and,
4. Amend the Fiscal Year 2024-25 budget in the amounts and in the accounts listed in Attachment E; and,
5. Provide City Council and allow time for Community Feedback on budget priorities for Fiscal Year 2025-26; and,
6. Take whatever additional actions necessary.

Director of Finance Michael Solorza provided a presentation on the item.

Councilmember Peralta inquired about the revenue generated by Topgolf, Metro Heights, and Tesla. Additionally, she asked how the MOUS for employee groups will be factored into the budget development for Fiscal Year 2025-26. She requested that staff provide answers at a future budget presentation.

Councilmember Alonzo highlighted the needs of South Montebello, including a police substation, event programming, and street repaving.

Mayor Pro Tem Tamayo encouraged the community to attend the Budget Meetings and provide feedback.

The City Clerk's Office acknowledged one (1) member of the public wishing to address the City Council. The Speaker was provided three minutes to address the City Council and said speaker card is on file at the City Clerk's office.

Councilmember Peralta motioned, seconded by Mayor Pro Tem Tamayo, to approve the item; the motion passed unanimously.

7. ADOPT PLANS AND SPECIFICATIONS FOR FABRICATION AND INSTALLATION OF FULL CAPTURE STORM DRAIN TRASH DEVICES ON LOS ANGELES COUNTY-OWNED CATCH BASINS AND AUTHORIZATION TO PROCEED WITH BID ADVERTISEMENT

RECOMMENDATION: It is recommended that the City Council:

1. Approve Environmental Assessment pursuant to Title 14 California Code of Regulations § 15301 as a Class 1 categorical exemption under the California Environmental Quality Act (CEQA); and
2. Adopt construction specifications for Citywide Catch Basin Connector Pipe Screen and Automatic Retractable Screen Inserts Installation Project – CP 931; and
3. Authorize staff to proceed with bid advertisement for construction; and
4. Take such additional, related action that may be desirable.

Councilmember Peralta motioned, seconded by Mayor Pro Tem Tamayo, to approve the item; the motion passed unanimously.

8. ACCEPTANCE OF THE MONTEBELLO CITY PARK BASEBALL FIELD RENOVATION PROJECT (CP NO. 928) – NOTICE OF COMPLETION

RECOMMENDATION: It is recommended that the City Council:

1. Accept the Montebello City Park Baseball Field Renovation Project (CP No. 928) as completed by California Landscape & Design; and
2. Approve the final contract amount with California Landscape & Design for the construction of the Project in the amount of \$969,068 including change orders; and
3. Approve the Final Total Project Budget (Attachment A); and
4. Authorize the City Clerk to execute, verify and file the Notice of Completion (Attachment B) with the Los Angeles County Registrar-Recorder; and
5. Authorize the release of the retention payment of \$48,453 due to California Landscape & Design following the mandatory waiting period from the date the Notice of Completion is recorded; and
6. Take such additional, related action that may be desirable.

Councilmember Peralta motioned, seconded by Mayor Pro Tem Tamayo, to approve the item; the motion passed unanimously.

9. APPROVE AMENDMENT NO. 1 TO PROFESSIONAL SERVICE AGREEMENT NO. 4180 WITH KIMLEY-HORN AND ASSOCIATES, INC. TO EXTEND THE COMPLETION DATE FOR BUS STOP IMPROVEMENT PROJECT CONSULTING SERVICES

RECOMMENDATION: It is recommended that the City Council:

1. Approve Amendment No. 1 to Professional Services Agreement No. 4180 (Agreement No. 4180) with Kimley-Horn and Associates, Inc. (Kimley-Horn & Assoc.), to extend the completion date for Bus Stop Improvement Project (BSIP) Consulting Services; and
2. Authorize the City Manager and/or his designee to execute Amendment No. 1 on behalf of the City of Montebello (City); and
3. Take such additional, related action that may be desirable.

Councilmember Peralta motioned, seconded by Mayor Pro Tem Tamayo, to approve the item; the motion passed unanimously.

10. AUTHORIZATION TO SUBMIT AN APPLICATION FOR THE OUTDOOR RECREATION LEGACY PARTNERSHIP GRANT PROGRAM

RECOMMENDATION: It is recommended that the City Council:

1. Authorize submission of an application for the Outdoor Recreation Legacy Partnership Grant Program; and

2. Authorize the Director of Recreation and Community Services to conduct all negotiations and execute and submit documents reasonably-necessary for the completion of the awarded project; and
3. Take such additional, related action that may be desirable.

Councilmember Alonzo spoke in support of the item.

Councilmember Peralta motioned, seconded by Mayor Pro Tem Tamayo, to approve the item; the motion passed unanimously.

11. AUTHORIZATION TO SUBMIT AN APPLICATION FOR THE LA84 FOUNDATION GRANT PROGRAM

RECOMMENDATION: It is recommended that the City Council:

1. Authorize the submission of an application for the LA84 Foundation Grant Program on behalf of the City of Montebello; and
2. Authorize the Director of Recreation and Community Services to conduct all negotiations and execute and submit documents reasonably-necessary for the completion of the awarded program; and
3. Take such additional, related action that may be desirable.

Councilmember Peralta motioned, seconded by Mayor Pro Tem Tamayo, to approve the item; the motion passed unanimously.

12. APPROVE INCREASING THE TOTAL NOT-TO-EXCEED AMOUNT FOR BLANKET PURCHASE ORDERS ESTABLISHED WITH WAYNE ELECTRIC COMPANY, AFTERMARKET PARTS COMPANY, LLC, AND DARTCO TRANSMISSION SALES & SERVICES INC

RECOMMENDATION: It is recommended that the City Council:

1. Approve an increase to the total not-to-exceed amount, from \$60,000 to \$80,000, for a blanket purchase order (PO) with Wayne Electric Company (Wayne Electric), to purchase maintenance-related bus parts, for Fiscal Year 2024-25; and
2. Approve an increase to the total not-to-exceed-amount, from \$200,000 to \$385,000, for a blanket PO with Aftermarket Parts Company, LLC (Aftermarket Parts), to purchase maintenance-related bus parts, for FY 2024-25; and
3. Approve an increase to the total not-to-exceed-amount, from \$49,000 to \$70,000, for a blanket PO with Dartco Transmission Sales and Service inc. (Dartco), to purchase maintenance-related bus parts, for FY 2024-2025; and
